This was after having 150 years of men holding this top position. She was one of the early women to be admitted a member, back in 1997. Since then, she has served on the General Committee with great enthusiasm and dedication for many years. First as a member, then as Honorary Treasurer, Honorary Secretary and Vice Chairman before she became Chairman.

She is a fully qualified Chartered and Management Accountant with a vast amount of experience in finance and administration. She was the first woman to be appointed to the Board and then as Group Finance Director of John Keells Holdings.

In accepting the position, Miss Anushya Coomaraswamy said that "In a world where women are still to be fully recognized and given their rightful place, the Colombo Club has been progressive and that must be acknowledged, appreciated and commended. And for me personally I thank you for your confidence".

CLUB COMMITTEE MEMBER MR. SIVAKUMAR NADESAN RECEIVES THE 2023 PRAVASI BHARATIYA SAMMAN AWARD

Mr. Sivakumar Nadesan, the Managing Director of the Express Newspapers, publishers of Virakesari, member of the Colombo Club, Chairman of the Sri Lanka Press Institute and the Press Complaints Commission of Sri Lanka received the Pravasi Bharatiya Samman Award from Her Excellency Droupadi Murmu, the President of India at the 17th Pravasi Bharatiya Divas 2023 Valedictory Session held on January 10 in Indore, Madhya Pradesh.

Mr. Nadesan, is the only Sri Lankan among 27 others selected globally to receive the coveted Award.



He is also a Member of Newspaper Society of Sri Lanka and is the President of the Global Organization of People of Indian origin (Sri Lanka) and has been a recipient of the "Service above Self" award from Rotary International for Community work.

A Jury-cum-Awards Committee, with Hon'ble Jagdeep Dhankhar, Vice-President of India as the Chairman and Hon'ble Subrahmanyam Jaishankar, External Affairs Minister as the Vice-Chair and other distinguished persons from various walks of life as members' considered the nominations for the awards and unanimously selected the awardees for conferment.

CLUB COMMITTEE MEMBER DR. PARAKRAMA DISSANAYAKE CONFERRED WITH LIFETIME "CHARTERED SHIPBROKERS UK" MEDAL



The Institute of Chartered Shipbrokers which was founded in London in the year 1911 and with a Royal Charter awarded in 1920, has conferred its Lifetime Chartered Shipbroker's Medal to Aitken Spence Deputy Chairman and Managing Director Dr. Parakrama Dissanayake.

Dr. Dissanayake pioneered Commercial Maritime Education in Sri Lanka through the Institution's branch in Sri Lanka as Founder/Secretary/Chairman. He was appointed as the first non-British International President of the Institute of Chartered Shipbrokers (UK).

Dr. Dissanayake has authored and presented numerous articles on Maritime and Logistics. He was the first-ever industry professional to be appointed as the Chairman of the Sri Lanka Ports Authority and for two stints.

He has held several other positions as the Secretary to the Cabinet Ministry of Ports, Shipping and Southern Development, Chairman of Chartered Institute of Logistics and Transport Sri Lanka, Chairman of Advisory Council to the Sri Lanka Transport Board, Board Director of the Ceylon Shipping Corporation and Chairman/CEO of Aitken Spence Maritime and Logistics, the first Sri Lankan Company to venture into Port Efficiency Management and launch two Public Private Partnerships on Ports outside Sri Lanka.

He is a Professor in Maritime Studies (visiting) at Shanghai Maritime University, Dalian Maritime University and Co-Chairman of CINEC Maritime Campus. He has also served on the UN/UNCTAD Panel as a Shipping Expert and is a Member of the International Association of Maritime Economist and Member of Colombo Club.
